## =DJ FOCUS: Rosneft Launches IPO, ButDoesn't Silence Critics

MOSCOW (Dow Jones)--OAO **Rosneft** (ROSN.RS) sold \$10.4 billion in shares Friday at a price that values the company at \$79.8 billion dollars, putting a market imprimatur on its status as Russia's second biggest company.

The \$7.55 a share price also placed **Rosneft** among the world's biggest oil company, putting it in the ranks of U.S major ConocoPhillips (COP), with a market cap of \$110 billion, and well above its Russian peer OAO Lukoil Holdings (LKOI.RS), with a market cap of \$70.9 billion.

The successful sale was a victory for Russian President Vladimir Putin, who defied critics who said the sale of about 15% ofthe state-owned company wouldn't succeed. The sale also showed that Western investors can't resist a potentially risky Russian equity in the feverish global energy market.
